Dear Exclusive Surveyors,

The purpose of this letter is to inform you of the updates in the Instructive for The Survey And Issuance Of Certification For The Prevention Of Pollution By Garbage From Ships, based on the amendments by IMO MEPC.360(79) & IMO A.1187(33).

- Paragraphs 5.2.5 to 5.2.8 have been included following the amendments of IMO MEPC.360(79) and MEPC.363(79).

5.2.5 *The following States may satisfy with the above, through regional arrangements when, because of those States' unique circumstances, such arrangements are the only practical means to satisfy these requirements:*

- .1 small island developing States; and*
- .2 States the coastline of which borders on Arctic waters, provided that regional arrangements shall cover only ports within Arctic waters of those States.*

5.2.8 *The Government of each Party participating in the arrangement shall consult with the Organization, for circulation to the Parties of the present Convention, on:*

- .1 how the Regional Reception Facilities Plan takes into account the guidelines developed by IMO;*
- .2 particulars of the identified Regional Ships Waste Reception Centers, taking into account the guidelines developed by IMO; and*
- .3 particulars of those ports with only limited facilities.*

- The procedure has been revised to incorporate the requirements of IMO Resolution A.1187(33)

This update will start on **September 15, 2024**.
